

**SALES TAX:** Access Securepak is required by the state of Georgia to collect 4% sales tax on all food items and 8% sales tax on all non-food items including the processing fee. Please see the tax calculation example below for more information.

# Tax calculation example:

\$25.50 food total x 1.04 (tax rate) = \$26.52 food subtotal \$12.75 non- food total x 1.08 (tax rate) = \$13.77 non- food subtotal

\$4.00 processing fee x 1.08 (tax rate) = \$4.32 processing fee subtotal

\$26.52 food subtotal + \$13.77 non- food subtotal + \$4.32 processing fee subtotal = \$44.61 total amount due
